Results of Interview

Clayton Woolley, age 5, was interviewed at his school. Worker introduced himself and explained his role to Clayton. Clayton agreed to visit with worker. Clayton was able to tell worker he was 5 1/2 years old and in Kindergarten. Clayton said he is playing Tball and likes it. Worker noticed Clayton had a speech issue and had trouble saying the "R sound" in words. Clayton appeared eager to talk with worker and talked rather easily with worker. Worker asked who lives in his home. Clayton said Elijah, Glory, Grandma, and Papa. Clayton was able to tell worker that Elijah was his little brother and Glory was Aunt Glory. Worker asked about his mom. Clayton said he sees his mom at Grandma and Papa's house but she doesn't live there. He did not know why she didn't live there. He said he sees his mom but not very often. Worker asked about his dad. Clayton said Papa is my dad. Worker said is papa your grandpa or your dad. Clayton said grandpa. Worker said tell me how things are going at your house. Clayton

said this morning he and papa talked about their dog who was not doing well. He said his dog was dying and he and papa talked about it. Worker asked Clayton what does he and his papa do for fun. Clayton said we don't do anything for fun. Worker asked him how he liked school. Clayton said he liked going to school. Worker asked Clayton if he knew what the word safe meant. Clayton said safe means "not to be bad". Worker said who can keep you safe at school. Clayton said teachers and he would tell his teacher if something bad was happening to him. Worker asked who can keep you safe at home. Clayton said Grandma Papa, and Glory. Worker asked Clayton what happens when he gets in trouble. Claytons said we talk about it and I get spanked. Worker asked Clayton who spanks him. Claytons said Grandma, Papa, Glory, and his mom all spank him like 100,000 times. Worker asked what he gets spanked with. Clayton then attempted to tell worker he was being spanked with what sounded like a "trainer". Clayton said the trainer a red one and a yellow one. Worker said when you get spanked do you have any marks. Clayton said no. Worker asked do you feel safe at home with grandma, papa, and Glory. Clayton said yes.
